



# Global torture prevention community calls for protection of Afghanistan's national preventive mechanism

We, the undersigned national preventive mechanisms (NPMs) and members of the torture prevention community, express grave concern for the threat posed by the recent Taliban military offensive to the continued independence and functioning of the Afghanistan Independent Human Rights Commission (AIHRC), and for the safety of its members and staff. We jointly call on those in power to respect the mandate and independence of the AIHRC and to ensure the protection of those involved in its work.

As United Nations agencies, international NGOs and Afghan civil society organisations have noted, civilians who have engaged in work to promote human rights and democracy now face a serious risk of reprisals under the Taliban.

Afghanistan ratified the OPCAT in 2018 and decided that the AIHRC would perform the NPM mandate. NPMs are independent bodies that visit places of detention, monitor conditions, interview detainees in private, prepare reports and engage in constructive dialogue with relevant authorities to implement recommendations that reduce the risk of torture and ill-treatment.

We know from our own experience that independent oversight is important everywhere and at all times and, in particular, during times of transition and crisis.

This kind of independent human rights monitoring – focused on those in situations of vulnerability – is emblematic of the hard-won progress that Afghanistan has made over the past two decades. This is the kind of progress that we have all fought for in our own jurisdictions. This is the progress we stand together to defend, wherever it is under threat.

The OPCAT is the international torture prevention treaty that has been operational since 2006. Ninety States have ratified the OPCAT, with more than 70 establishing NPMs. The OPCAT is clear that NPMs must be protected against reprisals and sanctions for the work they do. Annual resolutions of the UN Human Rights Council and the UN General Assembly also repeatedly call for the protection of national human rights institutions and their staff from threats, intimidation and reprisals.

As members of this global torture prevention community, we call on those in positions of power to stand by their international obligations to respect the independent work of the AIHRC and to guarantee the safety of its members and staff.
