# WHAT IS THE NATIONAL MECHANISM FOR THE PREVENTION OF TORTURE AND HOW DOES IT WORK?

It is an independent national body that pays inspection visits to places where people are, or may be, kept against their will.

The NMPT has been established pursuant to the Optional Protocol to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment (OPCAT).

On 18 January 2008, the role of the NMPT in Poland was assigned to the Commissioner for Human Rights.

### WHAT ARE THE INSPECTION VISITS?

The NMPT visits are preventive in nature and are not paid upon a complaint.

The visits are not announced in advance.

Their purpose is to verify whether mechanisms are in place to protect persons deprived of their liberty against violence or other forms of ill-treatment.



#### **EVERY VISIT INCLUDES:**

- an initial meeting with the head of the facility,
- an inspection of the facility's rooms and outdoor area,
- meetings with groups of detained persons and with individual detainees,
- meetings with staff members,
- review of documentation.

At the end of the visit, the NMPT presents its preliminary findings to the head of the facility. More specific information is contained in the post-inspection report.

#### **ART. 21 OPCAT:**

No person or organization shall be prejudiced in any way for having communicated any information to the national preventive mechanism.

#### WHAT IS TORTURE?

Torture is any act by which severe pain or suffering, whether physical or mental, is intentionally inflicted on a person.

If this is done or permitted by a state service officer or employee of any public facility (e.g. a police officer, social care home staff member, juvenile facility employee) – report this to the NMPT!
